Products to be used: SUREFIRE FENITROTHION 1000EC INSECTICIDE (APVMA No. 63674) PLUS OTHER REGISTERED PRODUCTS Containing: 1000 g/L FENITROTHION as the only active constituent.

RESTRAINT:

DO NOT apply this product by aircraft at rates greater than 350 mL/Ha.

Critical Use Comments:

- Apply aerially, or by boomspray, air assisted, misting or electrostatic ground application equipment.
- DO NOT apply more than 3 applications per paddock per year.
- DO NOT apply less than 7 days after the initial treatment.
- Prior to use, refer to the label General Instructions on Buffer Zones for the chosen application method and rate.

Withholding Period:

Grazing: Do not graze or cut for stock food for 14 days after application.

Jurisdiction:

QLD only. Specifically, within the Mitchell Grass bioregion.

Additional Conditions:

This permit allows for the use of a product in a manner specified on the permit. Persons who wish to prepare for use and/or use products for the purposes specified in this permit must read, or have read to them, the details and conditions of this permit. Unless otherwise stated, the use of the product must be in accordance with the product label.

Other Matters

Continued issuance of this permit is subject to the outcomes of the current APVMA review of fenitrothion. This permit may be impacted by the outcomes of this review.
