3. NOTIFIED ISSUES

To receive and consider advice from Director of Engineering Services regarding status of contract let by Council to Lillyman Earthmoving for the amount of \$1,019,356 for the supply and delivery of 21,150 cubic metres of category C gravel for the Flinders Highway Upgrade and if necessary, to cancel that contract and accept one of the other tenders as detailed in the DES report of 19 April 2016

4. **REPORTS FOR CONSIDERATION**

4.1 Flinders Hwy Upgrading Base Course Gravel Supply

A report was submitted in Council for the Briefing Meeting on Tuesday 5th April, 2016 for the supply and delivery of base course gravel for the TMR Flinders Highway project from Ch 96.000 to Ch 103.090 in sections – 12,000m3 to be delivered 45kms east of Julia Creek and 9,150m3 to be delivered 50 kms east of Julia Creek.

Tenders were assessed by Council and the Tender was awarded to Lillyman Earthmoving for the amount of \$1,019,356 for the supply and delivery of 21,150m3 of cat. C gravel.

Upon submitting information to TMR it was noted that Lillyman Earthmoving is not a registered supplier of quarry materials. On the 26th April, 2016 we received an Email from Lillyman Earthmoving that their tendered price was incorrect due to miscalculating the number of tons/cubic metre and therefore they could not fill the Tender for the price Tendered.
